How did you spend your pupil premium allocation last academic year?	During the last academic year we prioritized PP spending towards providing a welcoming, supportive environment for all children where their wellbeing is supported and where need is identified intervention is put in place. This included improving staffing support to provide small group, individual and class support for those requiring both emotional and learning intervention to enable them to be settled in learning and effectively close identified gaps. This included school wide strategies for wellbeing and related training for staff, provision of wider curriculum opportunities such as residentials and external visitors. PP and identified Vulnerable families continue to be monitored and where required support is actioned. The impact of our strategies is evidenced in the progress figures made for all our children last year (internal school data) and the lack of gaps between PP progress and their peers.
